The bid document shall be collected during office hours (Monday to Friday 8:00 - 12:00A.M., 1:00 - 4:15P.M.; and Saturday 8:00 -11:45A.M.).By presenting the payment invoice, copy of renewed Trade License, Tax Clearance Certificate and VAT Registration Certificate is a must. 4. Bid proposal shall be accompanied by the bid bond /Earnest Money Deposit/ in the amount as stated above in the table in the form of Unconditional Bank Guarantee or Cash Payment Order (C.P.O.). Bid bond /EMD in any other form is not acceptable.
