No. 1000134998028, to CBE Finance Process**. The bid document shall be collected during office hours (Monday to Friday 8:00-12:00 A.M., 1:00–4:15 P.M.; and Saturday 8:00-11:45 A.M.) by presenting the payment invoice. Presenting copy of renewed Trade License, Tax Clearance Certificate and VAT Registration Certificate is a must. And you can also access the bid document online from <https://bids.extratenders.com/>.
3. Bidders shall be quite sure to state direct line phone number, cell phone number, and e-mail address of their organization correctly while collecting bid documents. Failure in receipt of bid communication due to incorrectness of the above will not be the responsibility of the bank.
4. Bid proposal shall be accompanied by the bid bond / Earnest Money Deposit (EMD) in the amount **shown in the above table in the form of Unconditional and irrevocable Bank Guarantee or Cash Payment Order (C.P.O.). Bid bond / EMD in any other form is not acceptable.**
5. Bid bond **shall be presented with the Bid documents** in a separate envelope on or before **June 21, 2024 at 10:00 A.M** in the above mentioned address.
6. All bids must be deposited in the tender box prepared for this purpose at Commercial Bank of Ethiopia, Procurement Department, during office hours on/ before **June 21, 2024 at 10:00 A.M** at the place mentioned under no. 2 above.
