No.1000134998028 to the account of 'CBE Finance Process' account, in the name of the bidder. The bid documents shall be collected during office hours (Monday to Friday 8:00-12:00a.m., 1:00-4:15p.m.; and Saturday 8:00-11:45a.m.) by presenting the payment advice. Presenting copy of renewed Trade License, Tax Clearance Certificate and VAT Registration Certificate is a must.
3. Bidders can buy any bid documents of their limit grade but will not be awarded for more than two projects if they win more in this bid, previous bid and next bid announcements.
4. Any eligible contractor who do not have equal or greater than two contracts with the Bank and/or who do not have any poor performance history with the previous Bank projects can participate in this bid
5. Bidders shall be quite sure to state direct line phone number, cell phone number, fax number and e-mail address of their organization correctly while collecting bid documents. Failure in receipt of bid communication due to incorrectness of the above will not be the responsibility of the bank.
6. Conflict of interest will be investigated seriously. (Refer ITB clause 6 a- h on the Bid Document).
7. Bid proposal shall be accompanied by the bid bond/Earnest Money Deposit in the amount of Birr as stated above in the form of **Unconditional Bank Guarantee** or **Cash Payment Order (C.P.O.)**. Bid bond/EMD in any other form is not acceptable. The bid security shall be valid for twenty-eight days (28) beyond the end of the validity period of the Bid (i.e. Equal and greater than 118 days)
8. Bidders shall submit their bid proposal in tender box prepared for this purpose on or before February 11, 2025, at **2:00pm** in the above mentioned address.
9. Bid opening shall be held in the presence of bidders and/or their legal agents who wish to attend on **February 11, 2025, at 2:30 p.m.** at the place mentioned under no. 2 above.
10. Failure to comply any of the conditions from 2 - 8 above shall result in automatic rejection.
