(4:00 Local Time) for bid No. 57/2022/23 and Bid No. 61/2022/23.** All bid proposals must be deposited in tender box prepared for this purpose at Commercial Bank of Ethiopia Facilities Management Building, Procurement department, at CBE Facility Management meeting hall at the place mentioned under no.2 above, during office hours on or before **Nov. 30, 2022 at 10:00 A.M. (4:00 Local Time) for Bid No. 57/2022/23 and Bid No. 61/2022/23.**
