- **6.** All bid proposals must be deposited in tender box prepared for this purpose at Commercial Bank of Ethiopia Building, Procurement department, at CBE meeting hall at the place mentioned under no.2 above, during office hours on or before **February 21, 2025 at 02:00 P.M.** (8:00 Local Time).
- 7. Bid opening shall be held in the presence of bidders and or their legal agents who wish to attend, on February 21, 2025 at 02:30 P.M. (8:30 Local Time) at CBE Building meeting hall at the place mentioned under no. 2 above.
