4. Bid proposal shall be accompanied by the bid bond/Earnest Money Deposit in the amount as stated above in the table in the form of Unconditional Bank Guarantee or Cash Payment Order (C.P.O.). Bid bond/EMD in any other form is not acceptable.

5. Earnest Money Deposit (EMD)/Bid Bond shall be submitted with the bidding document in separate envelope on or before **February 21, 2025 at 02:00 P.M. (8:00 Local Time)**.

6. All bid proposals must be deposited in tender box prepared for this purpose at Commercial Bank of Ethiopia Building, Procurement department, at CBE meeting hall at the place mentioned under no.2 above, during office hours on or before **February 21, 2025 at 02:00 P.M. (8:00 Local Time)**.

7. Bid opening shall be held in the presence of bidders and or their legal agents who wish to attend, on **February 21, 2025 at 02:30 P.M. (8:30 Local Time)** at CBE Building meeting hall at the place mentioned under no. 2 above.

8. Failure to comply any of the conditions from 2 - 6 above shall result in automatic rejection.
